## 2023 State Legislative Session Summary and Highlights

The purpose of this report is to summarize and highlight legislation impacting the University of New Mexico enacted during the 60-day 2023 State Legislative Session, formally known as the First Session of the 56<sup>th</sup> Legislature. This report highlights the major appropriations bills and non-appropriation legislation.

## **Appropriations Summary**

The majority of this report will focus on the four major appropriations bills:

- HB2 General Appropriations Act,
- HB505 Capital Outlay Projects,
- SB309 Capital Outlay Reauthorizations, and
- SB192 Additional Appropriations and Confidentiality.

The General Appropriations Act, referred to a House Bill 2 (HB2), provides appropriations for the annual operating budgets for state agencies and higher education institutions. HB2 also includes nonrecurring appropriations for a wide range of purposes and programs. Below is a high-level summary of appropriations impacting UNM, followed by additional information grouped by key areas.

- For UNM Central Campus (excluding HSC), HB2 includes a total of \$248.3 million, or a 3.3 percent (\$8.0 million) increase, for **Instruction & General (I&G) funding, Categorical funding, and Research and Public Service Projects (RPSPs)**.
- For UNM Health Sciences Center (HSC), HB2 includes a total of \$139.2 million, or an 8.6 percent (\$11.1 million) increase, for Instruction & General (I&G) funding, Categorical funding, and Research and Public Service Projects (RPSPs).
- For UNM Branches, HB2 includes a total of \$25.6 million, or a 9.1 percent (\$2.1 million) increase, for Instruction & General (I&G) funding, Categorical funding, and Research and Public Service Projects (RPSPs).
- Additionally, related to compensation, HB2 includes partial funding for a 6 percent salary increase in
  FY24 for non-student faculty and staff in a budgeted position who satisfactorily completed their
  probationary period. At the time of publication, the final compensation distributions to individual
  institutions were not available. For more details, see pages 242 to 245 of HB2.

## Instruction and General Funding – HB2

**Instruction and General (I&G) funding** is recurring state general funds directly appropriated to the University. The purpose of I&G funding is to provide education services designed to meet the intellectual, educational and quality of life goals associated with the ability to enter the workforce, compete and advance in the new economy and contribute to social advancement through informed citizenship. For more details, see pages 140 to 147 of HB2.

- For Central and Branch campuses, the I&G increase was calculated by distributing 1 percent of "new money" through the higher education funding formula (Central: \$2.4 million, Branches: \$129 thousand), partial funding for a statutorily required 1 percent Educational Retirement Board employer contribution at a proportion of 85% of the I&G cost, and other considerations, including faculty compensation and student services.
  - o For Central Campus, HB2 includes a total increase of 3.1 percent (\$7.0 million) for I&G.
  - o For Branches, HB2 includes a total increase of 2.5 percent (\$563.8 thousand) for I&G.
- For HSC, the I&G increase was calculated by increasing the FY23 I&G base funding by 1 percent (because HSC is not included in funding formula distributions), partial funding for a statutorily required 1 percent Educational Retirement Board employer contribution at a proportion of 85% of the I&G cost, and other considerations, including faculty compensation and student services.
  - o For HSC, HB2 includes a total increase of 3.9 percent (\$2.9 million) for I&G.
- HB2 includes language allowing the Department of Finance and Administration to reduce general
  fund appropriations up to three percent to institutions whose lower level common courses are not
  transferrable or accepted among New Mexico's public colleges and universities.

## Research and Public Service Projects, Categorical and Other State Funds - HB2

Research and Public Service Projects (RPSPs), Categorical, and Other State Funds are recurring direct appropriations to the University for the specific programs and purposes identified in the line item. For more details, see pages 140 to 149 of HB2. The requests are organized into categories: "expansion requests" are existing line items in HB2 that are requesting additional funds; "new requests" are programs requesting to become line items in HB2; "continuing requests" are existing line items in HB2 that are requesting a flat appropriation; and other state funds from non-general fund sources. FY24 is the first year that appropriations from the opioid settlements in the Consumer Settlement Fund have been made.

- For the UNM system, HB2 includes a 14.9 percent (\$10.8 million) total increase for RPSPs, Categorical, and Other State Funds.
- For Central Campus, HB2 includes a 5.8 percent (\$1 million) total increase for RPSPs and Categorical funds.
- For HSC, HB2 includes a 15.3 percent (\$8.2 million) total increase for RPSPs and Other State Funds.
- For Branches, HB2 includes a 162.6 percent (\$1.6 million) total increase for RPSPs. The increase is driven by nursing expansion funds that were a nonrecurring appropriation for FY23 but made recurring for FY24.

## Other Appropriations and Transfers, including Major Scholarships - HB2

This section discusses **other appropriations** in HB2 to the University or to state agencies that may impact the University. These appropriations encompass a wide range of projects and programs, both recurring and nonrecurring. Nonrecurring funds generally fall into three categories: (1) special appropriations are one-time funds for purposes typically outside of the recurring state budget; (2) supplemental appropriations allocate funds to an agency or program for an anticipated shortfall during the current fiscal year; and (3) deficiency appropriations allocate funds to budget shortfalls during previous fiscal years.

Special appropriations directly to the University include:

- HB2 includes \$2.5 million for endowments for Native American studies.
- HB2 includes \$1 million for a telescope at the Taos branch.
- HB2 includes \$500,000 to support infrastructure for the statewide human papillomavirus pap registry.
- \$25 million included in HB2 for the bioscience authority, contingent on enactment of Senate Bill 382 or similar legislation, was vetoed. For more details, see <a href="mailto:page-227">page 227</a>.

Appropriations for the major scholarship programs include:

- HB2 includes a \$146 million in recurring funds for the Opportunity Scholarship Program, and a \$45 million nonrecurring appropriation to cover budget shortfalls in FY23.
- HB2 includes a \$40 million transfer for the Lottery Scholarship, and an additional \$24 million in budget adjustment authority to cover the FY24 cost of the Lottery Scholarship. During the 2022 Regular Session, \$130 million was transferred to the Lottery Scholarship Fund.
- HB2 includes \$10 million to provide scholarships to New Mexico high school graduates who are enrolled full-time in a master's or doctoral degree program in a science, technology, engineering, or mathematics. The scholarship awards are capped at \$7,200 per academic year. For more details, see page 224.

Appropriations for other higher education initiatives include:

- HB2 includes multiple appropriations to the Public Education Department related to K-12 workforce development. For more details, see pages 219 and 221.
- HB2 includes nonrecurring funds for the Higher Education Department statewide initiatives. See pages 223 to 226 and 242.
  - \$20 million for building renewal and replacement statewide, including up to \$5 million for demolition of buildings at higher education institution.
  - \$200,000 for a study of instruction and general base funding and research and public service projects.
  - o \$10 million for endowed nursing faculty positions statewide.
  - o \$5 million for public health programs at NMSU and UNM.
  - \$55 million to provide matching funds to state research universities to support innovative applied research that advances knowledge and creates new products and production processes in the fields of agriculture, biotechnology, biomedicine, energy, materials science, microelectronics, water resources, aerospace, telecommunications, manufacturing science and similar research areas. Earmarked amounts for specific projects and institutions were vetoed.
  - o \$2.5 million to continue the longitudinal data system project.
  - o \$7 million for shared services enterprise resource planning system.
- Additionally, HB2 includes funding for the Higher Education Department for adult basic education (\$2 million), integrated basic education and skills training (\$1 million), adult literacy program (\$750 thousand), high skills program (\$761 thousand). - HB2 transfers three 2022 appropriations from the Appropriation Contingency Fund to the General Fund. These funds include endowed faculty positions for nursing, social work, and Native American studies. See page 225.

Major appropriations to state agencies impacting HSC include:

- For the Human Services Department (HSD), HB2 includes \$1.4 million to ensure effective deployment and utilization of 988 crisis now mobile crisis teams.
- For HSD, HB2 includes \$2.5 million to establish a comprehensive reentry support pilot program to provide individuals reentering the community from incarceration with pre-release Medicaid capacity and connection to services and housing support.
- For HSD, HB2 includes \$60 million to contract with rural regional hospitals, health clinics, providers, and federally-qualified health centers to develop and expand primary care, maternal and child health and behavioral health services capacity in rural medically underserved areas. - For the Department of Health (DOH), HB2 includes \$4 million for mobile homelessness response.

#### Capital Bills – HB505 and SB309

During regular sessions occurring in odd-numbered calendar years, the Legislature and Governor usually consider **two capital bills**.

First, the Capital Outlay bill (HB505) includes capital projects funded by nonrecurring General Fund. This bill contains two types of appropriations: "statewide" and "individual policymaker" allocations.

Second, the reauthorization bill (SB309) includes changes to capital appropriations made in prior years. Reauthorization changes may include amending the purpose of the project, extending the reversion date, or modifying the fiscal agent that oversees the funds.

## **Summary of Non-Appropriation Bills**

During the 2023 State Legislative Session, 1,294 pieces of legislation were introduced, and the Office of Government and Community Relations tracked more than 400 bills, memorials, and resolutions related to the University. At the end of the session:

- 247 bills were sent to the Governor for consideration;
- 213 were signed;
- 14 were vetoed; and
- 20 were pocket vetoed.
